10 'Veilig voor Elkaar' rules

VEILIG VOOR ELKAAR

Ensuring the safety of everyone on or around our sites is a top priority for us. So we have drawn up ten rules that apply to everyone. To work safely, it is important that you know all the rules well. So please read them through carefully: this is not only important for your own safety but also that of your workmates.

1 **Keep your workplace safe; do not accept an unsafe working environment**

Your workplace must be safe. A safe workplace is tidy, protected and safe to access. If it isn't, then don't work. We do not accept an unsafe working environment.

2 **Always work with the correct approved tools and equipment**

Only work with tools and equipment that have been approved. They will not only be better to work with but also safer.

3 **Only do work that you are able and allowed to do**

Don't do work that you are not allowed to do and only work with permission. Naturally, you should only do work that you are qualified to do.

4 **Only start your work if you have answered all questions in the LMRA with 'yes'**

A Last Minute Risk Analysis (LMRA) is an important part of our safety protocol. Only start work if you can answer all the questions in this analysis with 'yes'. If you are unsure about any of the answers, don't start work.

5 **Always wear the required PPE and workwear**

Naturally, you must always wear the required PPE and workwear. If you don't know what PPE or clothing is required for your work, contact your line manager.

6 **Draw each other's attention to unsafe situations and be open to others drawing your attention to them**

We comply with rules and arrangements. If someone is working unsafely, draw their attention to it. Likewise, be open to other people drawing your attention to a hazardous situation. This way we can keep each other vigilant. Report accidents, unsafe situations, environmental incidents and damage in the 'Veilig voor Elkaar' app. Naturally, you must also keep your line manager informed at all times.

7 **Know what the hazards and risks of hazardous substances at your workplace are**

If you work with hazardous substances, it is important to know what the risks are. Use the substances as instructed in the manual. Also use the Safety Data Sheet (SDS). Avoid breathing in dust, exhaust gases and welding fumes. Store hazardous substances in the correct room that meets the storage requirements.

8 **Make sure you are visible and be alert to warnings and alarm signals**

Make sure you are always clearly visible. Also make sure you can hear warnings and alarm signals. Keep away from hazardous places, such as under a suspended load or in a blind spot of heavy equipment.

9 **Protect yourself and others against the risk of falling when working at height**

Take suitable measures when you have to work at height. Always wear a fall protection harness when working at height. Never make any changes to scaffolding, edge protection, covers over recesses or openings and other safety features.

10 **Never work under the influence of alcohol or drugs and never take medicines that affect your performance**

Working safely should come naturally to you. In order to work safely, you must be alert at all times. Naturally, you must not take any substances that could affect your performance.

Give each other tips if there is a safer way of doing something!

We all take responsibility for our safety together and we comply with rules and arrangements. If you see instances of these rules being broken at the work site, draw people's attention to them or report them in our 'Veilig voor Elkaar' app.
